In supersession of this Ministry sanction letter of even number dated 1st September, 2015 (copy Sir, enclosed), making release of Rs. 10,00,00,000/- as an advance to Five Union Territories, I am directed to convey the sanction of the Competent Authority for the release of Rs 2,00,00,000/- (Rupees Two Crore only) as advance to Union Territory of Daman & Diu in respect of Diu as part of State/UT Funds for Administrative & Office Expenses (A&OE) for preparation of Smart City Proposal (SCP) in terms of Para 12.1 of SCM guidelines.

- The amount of advance will come from the city's share of the A&OE funds and will be adjusted 2. in the share of the city at the time of release of first instalment.
- The aforesaid sanction is subject to the following conditions: 3.
 - The sanction shall be regulated in accordance with the provisions of GFR, 2005/SCM guidelines.
 - The Union Territory of Daman & Diu would maintain a separate account in respect of SCM. i. ii.
 - The money will be utilized for the purpose for which it has been sanctioned. iii.
 - The Union Territory of Daman & Diu will furnish utilization certificate in respect of funds released at an early date in the prescribed Performa as provided in the SCM guidelines. iv.
- This is the first release to Union Territory of Daman & Diu under SCM guidelines. As such, no Utilisation Certificate is pending in respect of the Union Territory of Daman & Diu as per requirement.
- The expenditure involved will be debited to the Major Head 2217-Urban Development, 05-Other Urban Development Schemes, 191-Assistance to Municipal Corporation, 15-Mission for 100 Smart Cities, 15.00.31-Grants-in-aid General under Grant No. 104-Ministry of Urban Development of the year 2015-16 (Plan).
- The amount of Rs. 2,00,00,000/- (Rupees Two Crore only) may be transferred to Union Territory of Daman & Diu through Reserve Bank of India as per procedure laid down by Ministry of Finance, Department of Expenditure vide OM No. F-II (45/76/SC) dated 22.02.1977.
- This issues with the concurrence of Integrated Finance Division vide their Dy. No. 1012/US (D-II)/FD/15 dated 28.08.2015.
- The Sanction has been registered at Sl.No. 2 of the Sanction register of Smart Cities Division (SC-1) for the year 2015-16.
- Release order in respect of other four UTs namely Andamn & Nicobar, Chandigarh, Dadra & Nagar Haveli and Lakshadweep will be issued separately in terms of Ministry of Finance OM No. 9. 1(8)(1)/TA/2010/31 dated 31.01.2011.
