Subject:- Key activities for shortlisted cities in Round 2 of the smart city challenge process.

The undersigned is directed to refer to this Ministry's OM of even number dated 2nd February 2016 conveying results of Round 1 and to say that the Round 2 of the challenge process will start with 1st April 2016 and cities have to submit the revised Smart City Proposals (SCPs) to this Ministry by 30th June 2016 in the similar manner as done in Round 1.

- 2. Generic Observations of the Panel of Experts have already been conveyed to States/UTs for revision of SCP vide D.O. Letter of even number dated 12th February 2016. Further, the experience of winning city proposals has shown that successful cities have used external resources organization/individuals and mentoring institutions, in addition to consulting firms. Accordingly, MoUD has identified Training Institutions/Mentoring Institutions and External Agencies to support cities in upgrading their proposals. The cities are free to engage with any of these agencies or engage any other organization as provided in their rules and regulations. The funds from A&OE expenses may be used in this regard.
- 3. To systematically revise the SCP in a time-bound manner, attached is the list of key activities together with the timelines to start and complete the activities. The most competitive proposal will be the result of systematic and timely completion of activities as set out in the attachment. The States/UTs may add any number of additional activities/sub-activities and not limit themselves to the attached list, only.
- 4. Citizen engagement is a key element of the preparation of the Smart City Propsoal. Detailed instructions were issued during Round 1. These may be followed and in case MyGov is used, you may contact: Shri Gaurav Dwivedi, CEO, MyGov. Email:-gauravdwivedi@gov.in, Phone no: 011-24364706.
