3 Background Information

3.1 Basic Information

JSCL proposals ("Tenders") to this Expression of Interest ("EoI") from Smart Heath solution. The sole objective of this document is to solicit Expression of Interest (EOI) from eligible entities. ASeparate Request for Proposal (RFP) would be issued post the EOI for Smart Health.

3.2 About Jabalpur

Jabalpur is a city with prime regional importance and syncretic culture. It is the third largest city in MP by population, and the lynchpin for the region's economy.

Jabalpur has been selected by Ministry of Urban Development (MoUD), Government of India among the first 20 cities for implementation of projects Smart City mission. As part of the Smart City Proposal, the city of Jabalpur has set its vision for Smart City as follows

"Transforming Jabalpur into a vibrant regional economic and cultural hub through inclusive urban regeneration, to act as a magnet for investment and new opportunities for the youth."

3.3 About Jabalpur Smart City Ltd

In line to the guidelines issued by Ministry of Urban Development (MoUD)/ Government of India (GoI) Government of Madhya Pradesh has created a Special Purpose Vehicle (SPV) Jabalpur Smart City Ltd (JSCL) for implementing the Smart City mission at the city level.

JSCL will plan, appraise, approve, release funds, implement, manage, operate, monitor and evaluate the Smart City development projects. JSCL is headed by a full time CEO and have nominees of Central Government, State Government and ULB on its Board.

The key functions and responsibilities of JSCL are to;

- i. Approve and sanction the projects including their technical appraisal
- ii. Take measures to comply with the requirements of MoUD with respect to the implementation of the Smart Cities programme
- iii. Undertake review of activities of the Mission including budget, implementation of projects, etc and co-ordination with other missions / schemes and activities of various ministries

3.4 Project Objectivists

The strategy of Smart Health is based on the providing cheaper doctor consultation, reasonably priced medicines and affordable diagnostics. This can be done by converging different schemes.

To creating and nurturing a common platform between patients, doctors, diagnostic centres, blood bank and chemists to provide the best possible healthcare delivery to citizens of Jabalpur.

3.5 Project Description

Create IT enabled services for efficient & convenient health solution.

This will help physicians and healthcareprofessionalsto providers manage and treat patients online and gain medical education. The key points are:

- a) Online Consultation: For institute round-the-clock doctor consultation, a unique version of telemedicine can be designed by establishing an IT platform to match patients and doctors, bringing convenience to patient doorstep. Doctors volunteering for this programme will provide services to patient on their mobile phones. Provide various suggestions for precaution of general disease and good health. Suggestion regarding good health and special nutrition for pregnant women, children, patient etc.
- b) <u>Provide affordable quality medicines: -</u> Provide delivery of free medicine from various available Health schemes of Central and State government.
- c) <u>Delivering affordable Diagnostics</u>: -Complementing the free medicine scheme, free diagnostic services can also be made available under a hub-and-spoke model, floated by the Ministry of Health under the Free Diagnostics Services Initiative (FDSI). Under this scheme, a set of essential diagnostic services at each facility level has been identified.
- **d)** Citizens can book online appointment with doctors, they can order some generic medicine through App from Registered Stores
- e) Provide medical solution of periodically weather base diseases or any epidemic.

- f) Provide facility to search and view of availability of nearest Hospital, Specialist Doctors, and Bloodbanketc.
- g) Smart Health Solution will be integrate on existing app of JSCL (One App for all).

The business model will be a Public Private Partnership (PPP) model. JSCL will not contribute any fund for this project.

- Suggest, with proper justification, the various revenue modes which can be part of the EOI. JSCL will consider these suggestions while evaluating the EoI.

Post the technical presentation the Bidder has to show such-type of application in running condition.

- The Bidders has to demonstrate the solution as per following;
 - o At least 1App or websitefor IT enabled system of Health solution.
 - o Interface with each other on a common communication platform
 - The demonstration/presentation should provide a representative solution to integrate various aspects of the project as per the scope
