NOTIFICATION

Government of Odisha, after careful consideration have been pleased to set up a Special Purpose Vehicle (SPV) Company namely "Rourkela Smart City Limited" for implementation of Smart City Mission programme in Rourkela Municipal Corporation (RMC) as per the Smart City Mission Statement and Guidelines of the Ministry of Urban Development, Govt. of India.

 (a) The Board of Directors of Rourkela Smart City Ltd shall comprise of the following members:

(v) Chief Executive Officer, Routkela Steel Plant	Director

(vii) Vice-Chairman, Rourkela Development Authority (RD	A): Director
(viii) Municipal Commissioner, RMC, Rourkela.	Director
(ix) Additional District Magistrate, Rourkela:	Director
(x) Chief Executive Officer of SPV:	Director
(xi) Independent Director (5 nos of which at least 1 will be	woman): Director

(b) In addition to the above, Additional Directors (such as representatives of Parastatal) may be taken on the Board if considered necessary apart from the CEO and Functional Directors. In case the Government of Odisha modifies the composition of directors of the company by issue of Notification, the composition of the Board shall be amended accordingly subject to retaining the representation of the Central Government and proportionate representation of Independent Directors. 3. The SPV shall be incorporated as a Limited Company under Companies Act, 2013 and the Promoters of the Company are Government of Odisha (GoO), Rourkela Municipal Corporation (RMC), Rourkela Development Authority (RDA).

- (i) The Authorised Share Capital of the SPV shall be Rs.500 erore consisting of 50,00,00,00 equity shares of Rs.100/- each.
- (ii) The initial Paid Up Capital of the SPV shall be Rs.250.00 crore divided into 25,00,00,00 equity share of Rs. 100/- each.
- The Registered Office of the SPV namely, "Rourkela Smart City Limited" shall be at Rourkela in the district of Sundargarh, Odisha.
- The key functions and responsibilities of the SPV, "Rourkela Smart City
 - i. Approve and sanction the projects including their technical appraisal.
 - Execute the Smart City Proposal with complete operational freedom.
 - iii. Take measures to comply with the requirements of the Ministry of Urban Development/other Ministries/Departments of the Government of India/State Government Roles and regulations, local laws etc. for implementation of the Smart City Programme.
 - Mobilize resources within timelines and take measures necessary for the mobilization of resources.
 - Approve and act upon the reports of a third party Review and Monitoring Agency.
 - vi. Oversee Capacity Building activities.
 - vii. Develop and benefit from interlinkages of academic institutions and organizations.
 - viii. Ensure timely completion of projects according to set timelines.
 - ix. Undertake review of activities of the Mission including budget, implementation of projects, preparation of Smart City Proposal (SCP) and co-ordinate with other missions/schemes and activities of various Ministries /Departments.
 - Monitor and review quality control related matters and act upon issues arising thereof.

- xi. Incorporation of joint ventures and subsidiaries and enter into public Private Partnerships including with the foreign entities as may be required for the implementation of the Smart City Programme.
- xii. Enter into contracts, partnerships and service delivery arrangements with ludian as well foreign firms, as may be required for the implementation of the Smart Cities Mission.
- xiii. Determine and collect user charges as authorized by the ULB.
- xiv. Collect taxes, surcharges etc. as authorized by the ULB.
- xv. Any other functions as delegated by the Central Government/State Government/ULB within the scope of Smart Cities Mission.

 of Association of the SPV.
